TERMS & CONDITIONS FOR SIKA NZ PROMOTIONS

PRIZE DRAWS:

- 1. Sika NZ's decision is final and no correspondence will be entered in to.
- 2. **"Winner"** is defined as the person whose name is drawn in the prize draw.
- 3. The Winner will be notified by telephone within 7 days of the prize draw. The Winner must respond within seven days or the prize will be forfeited and another Winner drawn.
- 4. The new Winner will be subject to the same terms and conditions.
- 5. If the new winner does not respond within seven days Sika NZ reserves the right to dispose of the prize at its discretion.
