#### DESCRIPTION

Sika<sup>®</sup> Fibermesh<sup>®</sup>-150, micro-reinforcement system for concrete—100 percent virgin homopolymer polypropylene multifilament (monofilament) fibers.

#### USES

Sika<sup>®</sup> Fibermesh<sup>®</sup>-150 act mechanically by supporting the aggregate within the concrete with multidimensional fiber network and developing a uniform bleed system. The fiber does not affect the curing process chemically and does not absorb water. The Sika<sup>®</sup> Fibermesh<sup>®</sup>-150 can be used in all types of concrete applications to control plastic shrinkage and settlement cracking. Typical applications include:

- Slabs on ground
- Residential applications: side-walks, driveways, decks, curbs
- Precast elements,
- Overlays / toppings
- Stucco

- Shotcrete
- Roads / Pavements
- Bridge Decks

Recommended Dosage	The dosage of the Sika <sup>®</sup> Fibermesh <sup>®</sup> -150 will vary according to the type of application and performance requirements. Standard recommended dosage ratio of Sika <sup>®</sup> Fibermesh <sup>®</sup> -150 is 1.0 kg/m <sup>3</sup> of concrete. For explosive spalling resistance the dosage rate will be between 1.0 kg/m <sup>3</sup> and 2.0 kg/m <sup>3</sup> , depending on the design requirements. Dosages outside the recommended dosage range can be used to meet project specific requirements.
