APPLICATION INFORMATION

Recommended Dosage	Typical dosage rates of SikaGrind®-400 are between 0.3 - 0.6 kg per ton of cement (0.03% - 0.06% of total weight). The optimum dosage to achieve the desired characteristics shall be determined in plant trials. Influencing factors are e.g. the properties of clinker, type of cement and other plant variables.
Dispensing	For consistent results, SikaGrind®-400 must be accurately dispensed. SikaGrind®-400 is added onto the clinker feed shortly before the mill en- trance or directly into the grinding mill. Suitable dosage pumps with ad- justable flow rates shall be used for accurate dosing. Note: Periodically, the end of the additive tube/hose shall be checked to ensure that it is not blocked!
Compatibility	Cements treated with SikaGrind [®] -400 are compatible in concretes pro- duced with all commercial admixtures including air entrainers, water redu- cers, retarders and superplasticizers. The performance of concrete admix- tures are not adversely affected by the use of SikaGrind [®] -400.
