All technical data in this document are based on laboratory tests. Actual measured data may vary due to circumstances beyond our control.

IMPORTANT CONSIDERATIONS

- Do not install Sikafloor® Level PRO over particleboard, hardwood floors, parquet floors or metal.
- Do not mix or apply Sikafloor® Level PRO in temperatures below 10°C and above 35°C and under hot and windy conditions.
- Protect from hot or strong winds for 12 hours after being applied to avoid rapid moisture loss leading to cracking or crazing.

- All construction/expansion joints in existing concrete must be reflected through Sikafloor product as soon as possible to do so - wet sawing is not recommend.
- Not recommended as a trafficable surface.
- Do not use on sloped surfaces that require drainage.
- Do not use in exterior applications.

APPLICATION INSTRUCTIONS

SUBSTRATE PREPARATION

Concrete floors should be fully cured, structurally sound, >20 MPa, clean, dry, and free of surface contaminates and dust. For example, concrete must be porous and accept water penetration. Test by lightly sprinkling water on various areas of the substrate. If water penetrates, then a good bond with a selected primer can be achieved. If water beads and fails to be absorbed by the concrete surface contaminants arepresent then loss of adhesion may occur. Contaminates that are present should be mechanically removed before installation. Ambient temperature, surfaces and materials should be maintained at temperatures higher than 10°C and less than 35°C directly prior to application. Concrete must be free of efflorescence and not subject to hydrostatic pressure. If the concrete substrate has efflorescence or high moisture (RH) a Sika Moisture Barrier System should be considered. Contact your local Sika office for current system information.

PRIMING

<u>Internal Porous Priming:</u> Sika® Primer-11 W+ or Sikafloor ®-01 Primer.

<u>Internal Non-Porous Priming</u>: Eco® Prep N Prime – undiluted/neat.

Note: When applying primer to a non-porous surface, use a paint roller and apply one thin even coat. Prep N Prime **must be completely dry** prior to applying cement compounds. Dry time 40+ min @ 23°C. Primer should be allowed to dry as recommended for the specific primer prior to the application of Sikafloor® Levelling Systems.

EOUIPMENT

Heavy duty electric drill and mixing paddle (500 rpm) and a suitable sized mixing bucket/vessel.

MIXING

Mix the entire 20kg bag of powder with 5 - 5.2 Litres of clean, cool water. When applying above 20mm Sika® recommends 5L be added. Slowly add powder to the water while mixing with a suitable electric drill and mixing paddle. Thoroughly mix for 2 minutes to a lumpfree consistency. Not mixing for the recommended time or additional water may result in product irregularities and possible product failure.

APPLICATION

Pour or Pump name, then spread with a long handled gauged spreader to heights as required. Sikafloor® Level PRO will seek its own level during the first 15 minutes. For touch-ups, use a flat steel trowel.

CLEANING OF EQUIPMENT

Clean tools and equipment with warm water and detergent while the product is still uncured.

MAINTENANCE REQUIREMENTS

There are no maintenance requirements for this Sika product
