LIMITATIONS

- Will remove the lacquer coating from Sarnafil® EL membranes.
- Dissolves thermoplastics not resistant to solvents (e.g. polystyrene, polycarbonate, acrylics)
- Do not use the cleaner to wash large areas of roof surface.
- Sarna® Cleaner should only be used on heavily soiled areas.
- White cloths will effectively absorb dirt and the colour will not stain the membrane.
- Sarna® Cleaner contains high volatile and flammable solvents. Application in closed rooms is allowed only with sufficient room ventilation. Smoking and open fires are not permitted.
- Use solvent resistant gloves and eye protection during application
